



# ID Requirements For Your PNCB Exam


***On-Site Exams - Don't forfeit your fees!*** To gain admittance to your on-site exam, you must present two forms of current (non-expired) identification, one with a photograph and both with signatures. All documentation must be in your legal name with the first and last names matching the names used on your exam application.

If your name changes prior to your scheduled examination or your ID/name on exam application do not match, you must contact PNCB by emailing [exam@pncb.org](mailto:exam@pncb.org) or calling 1-888-641-2767 regarding this change at least 5 business days prior to your certification exam date.

<h2 style="color: red; font-weight: bold;">Unacceptable ID Examples</h2> <p style="color: red; font-weight: bold;"><i>All fees will be forfeited, and candidate will not be admitted to your appointment to take the certification exam:</i></p>	
<p>A marriage license/certificate or divorce decree is NOT an acceptable form of identification. Name changes must be made with PNCB at least 5 business days prior to exam date.</p>	
<p>Temporary ID, certificate of naturalization, social security cards, RN licenses and ID cards such as PALS, ACLS, etc. are NOT acceptable. PNCB does not accept electronic versions of any identification used for admittance to take the exam.</p>	
<p>Testing vendors have the right to decline any PNCB exam candidate with questionable identification.</p>	

**Live-Remote Proctored Exam - Don't forfeit your fees!** To gain admittance to your live remote proctored exam, you must present one form of current (non-expired) identification, one with a photograph and signature. All documentation must be in your legal name with the first and last names matching the names used on your exam application. This must be a valid, government-issued, photo-bearing identification.

If your name changes prior to your scheduled examination or your ID/name on exam application do not match, you must contact PNCB by emailing [exam@pncb.org](mailto:exam@pncb.org) or calling 1-888-641-2767 regarding this change at least 5 business days prior to your certification exam date.

<h2>Unacceptable ID Examples</h2> <p style="text-align: center;"><i>All fees will be forfeited, and candidate will not be admitted to your appointment to take the certification exam:</i></p>
<ul style="list-style-type: none"><li>• A marriage license/certificate or divorce decree is NOT an acceptable form of identification. Name changes must be made at least 5 days prior to exam date.</li><li>• Temporary ID, military ID, certificate of naturalization, social security cards, RN licenses and ID cards such as PALS, ACLS, etc. are NOT acceptable.
