

## 2021 Continuing Competence Summit Speaker Biographies



PNCB Board Chair **Michael A. Maymi DNP, APRN, CPNP-AC, CCRN, CNE** is a Clinical Assistant Professor and Track Coordinator for the Pediatric Acute Care and Primary Care Programs at the University of Florida. His clinical practice is in the Pediatric Intensive Care Unit at UFHealth Shands Children's Hospital. He has been a pediatric nurse for the past 23 years with the last 10 years of experience as a nurse practitioner. He received his nursing diploma from Beebe School of Nursing, BSN at Florida State University, MSN at the University of Alabama at Birmingham, and DNP at the University of Florida. Over the course of his nursing career, he has worked in various leadership positions as a clinical leader, Lead Nurse practitioner, and manager of advanced practice. He has participated in several pediatric cardiac surgery missions for children in Jamaica and the Dominican Republic. Throughout his career he has presented at local and national conferences.
